If we receive your application after November 24, 2023, the time may be insufficient for mailing and receipt of the ballot; in those cases, we will ask that you arrange to pick up the mail ballot package from the School Board Office.
3. To be counted, your completed mail ballot must be received either at the School Board Office before 4:00 p.m. on December 8, 2023, or in person at either of the voting locations before 8:00 p.m. on December 9, 2023. You are responsible for ensuring that your completed ballot and documents are received by the Chief Election Officer by these deadlines.
