## PERSONAL INFORMATION CONSENT FORM

Schools and Districts are authorized to collect, use, and share student personal information that is directly related to and necessary for their educational functions. For other school or education-related purposes, parental/legal guardian (*and secondary school aged student*) consent is required.

**This consent will be considered valid from the date it is signed and will remain valid for the duration of your child's enrollment at the school, unless consent is withdrawn in writing to the child's school principal by the parent/legal guardian or significant changes are made to the consent form by SD46. Note: Withdrawal of consent does not require the school or SD46 to take any steps to withdraw from publication any previously published material.**
