- Grade 8's were surveyed at Chat and Elphi (170 students).
- 911 protocols discussed.
- Information form Safe Schools submitted for the minutes.
- Next In The Know session on Wed., Feb. 22<sup>nd</sup>.

*Superintendent's Report:*

Patrick Bocking followed-up with further discussions on the Healthy School's meeting; affirming the value of partnerships.

FSA finished soon and to be marked by the end of February.

Discussion on the amount of illness in schools over the last two months.

Emergency Preparedness session coming soon for school teams.

Reporting structure update and overview of the Ministry reporting order.

District Innovation grant allowed Fresh Grade pilot in 5 schools. Data from a questionnaire at WSES indicated that a full implementation would be welcomed by the school community.
