Technology is about communication

Students use it as a tool to support their learning. It is also how we communicate with students, parents and community.

- a. Report cards (1highschool paperless parents login) access attendance, way for school to communicate, to publish forms.
- b. Fresh grade APP gives parent's access from posts from teachers on day to day basis.
 Video/pictures/words. Parents can comment back.

40% teachers are reporting on fresh grade great way to communicate and get information and to be engaged with child about class.

- c. School messenger email and voice messaging events (ability to send out 500 calls per min in case of emergency).
- d. MyEd can send emails from admin or teachers.
 Available at every school.
- e. Appeture (APP) to get notifications from school, important events, teacher msg. The high schools have it. Alternative school does not.
- f. My Blueprint a way for students to communicate career path choices and opportunities.
- g. District website (getting revamped) 2019 will have new look. Spring 2019 our school websites will be updated. New system will be set from district level and will be set to all levels at same time – passing information very quickly.
- h. TV displays to be used in Schools. Such as Foyers. Highlights what is happening in the school. Move towards it be standardized between all schools. Elphi has menu on screen. Library has screen. Intention is to walk in School door and to know what's happening.
- Using twitter, facebook and Utube. Teachers and staff looking for training and support for Utube. Live streaming to set up for that. And archiving it. Mini courses on excel, and engaged site. Utube will be posted on our site. Tech.sd.bc.ca
- j. Internally system called Engage. For our staff. Opportunity to share our resources and learning material.
- k. In class High school google classroom letter from principle and consent form for google classroom. Set up on our own domain. We have more control with activity as it's our own domain. Gives great training for our students.

L. We use another product 'google read and write'. Students use for writing and research. Can cut and paste. Read and write is a simple program for the students to use.

CPen can read text to you. Student has headset and CPen will read text by scanning.

Google has a lot of class products available such as:

Google expeditions –app- over 800 places, allows a teacher to pick a location around the world. The teacher can lead the expedition with the students. Gives 3D view, brings the world to the student. Also it can be a great research tool.

Question: where can we get the cardboard stands to utilize this program?

It has been a priority to improve and/or replace equipment and increase bandwidth also improvements for infrastructure. Upgrade from30 to 200meg service.

There is a need to train teachers on new technology and to replace computers to have improved technology for the teachers.

To get more carts for the teachers. Also to get IPads for EAs in the school for them to support the learning of students and to take notes. M. Strategic plan for technology coming out this Fall 2019

Guides our direction to support the learning of students.

Question: Scott Davis – How fast is technology changing. Answer: The demand for bandwidth is sky rocketing. Fiber optics value 50,000 each school has one valued around 15,000. Technology is changing with the priority to provide faster smoother service. Plan is a replacement cycle for all infrastructures.

2. Grant money use – Proposal to fund a further Parenting Teens workshop at Elphinstone Secondary and possibly a 3rd at Pender Harbour Secondary. Request for Funding as current Parenting Teens workshop

has been waitlisted. Funding may have to include paying \$1200.00 for training at Elphinstone.

Facilitators only ones trained. It would be possibly too cramped for <u>all</u> schools in Spring2019 to have workshop. Another option could be funding for the Fall 2019 at Pender Harbour Secondary.

If there is a continued need for this workshop. DPAC cannot continue to fund. Want to be open to fund other Parent Education options.

Propose motion to spend \$600. Per school. With the funds needing to be matched.

Amy Robinson: Proposes motion. Scott Davis 2nd All in Favor to fund 50% of the cost of the Teen workshop.
